## TERMS AND CONDITIONS

- 1. The intending bidders should mention their turnover in the last three (03) Financial Years from "maintenance of computer hardware" supported by Chartered Accountant's Certificate.
- 2. The intending bidders should have executed a single AMC order with minimum 200 Nos. and above All-in-One Personal Computers in each of the last three (03) Financial Years (2021-22, 2022-23 & 2023-24). Copies of the Work Order / AMC orders should be furnished along with the bid.
- 3. The intending bidders should have Registered H.O/Branch Office at Hyderabad and running for last two (02) years as on bid calling date. Service Tax registration certificate should be submitted.
- 4. The intending bidders shall quote for AMC proposal with one Resident Engineer and shall quote AMC for all items but not piecemeal.
- 5. The Scope of Annual Maintenance Contract is preventive as well as comprehensive one i.e., promptly repairing/replacing damaged parts like Chipsets, SMPSs, Electronic Circuits, plastic parts, CPU Cooling fans, Motherboards with equivalent cabinets, changing the nonworking mouse & Keyboards with equal or high configuration, installing the Operating System Softwares and other software provided by the High Court and all other related activities both hardware and software at the cost of the Annual Maintenance provider.
- 6. The successful bidder has to keep 05 Nos. of working USB Mechanical keyboards, 05 Nos. of working USB Optical Mouses, 05 Nos. of compatible Motherboards and 05 Nos. of Power adaptors for the AIOs as standby in the High Court for immediate replacement.
- 7. If the defective All-in-One Desktop Personal Computer (AIO PC) is not made operational beyond 48 hours, during AMC period, the successful bidder will be required to provide stand-by (AIO PC) of the same or higher configuration, failing which a penalty of Rs.200/- per day till the (AIO PC) is rectified will be imposed after 48 hours.
- 8. The successful bidder shall provide one (01) Qualified & Experienced Resident Engineer in the High Court on all working days during the working hours for the maintenance of the above Computer hardware.
- 9. The successful bidder will have to furnish Unconditional Bank Guarantee @ 10% of the AMC value to the High Court for the State of Telangana valid for one (01) year within 15 working days of issue of Purchase Order, towards service guarantee.
