2. The Pay of the officer selected on deputation will be governed in accordance with DOP&T O.M No 6/8/2009-Estt (Pay II) dated 17.06.2010, as amended from time to time.

3. The maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of applications.



4. The maximum age limit for the re-employment on contract basis is 64 years. Gross pension will be reduced from the pay fixed.

5. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other Government Organization / department shall ordinarily not exceed **three years**.

6. Application (s) in the prescribed Proforma (Annexure I) from eligible officer (s) who can be spared for deputation in the event of their selection may be forwarded to the Principal Registrar, AFT, Principal Bench by the departments latest by **15th October, 2015 (Thursday)** along with photo copies of the annual confidential reports for the last five years of the candidates.

7. The applicant (s) interested in applying, for the post of Registrar on re-employment on contract basis for a period of one year may send application (s) to the Principal Registrar, AFT, Principal Bench directly by the aforesaid date along with copies of all the relevant documents like PPO, Date of Birth Certificate, LLB certificate, experience certificate etc.
