Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declare the action of the 2nd respondent in not permitting the petitioner to register his online application for admission into MBBS/BDS courses under Management Quota B & C Category for the academic year 2024-25 pursuant to the Notification dated 17.08.2024, on the ground that the petitioner is failed to registered within time schedule i.e 6 am on 18.08.2024 to 5 PM on 23.08.2024 is illegal, arbitrary, unconstitutional and consequently direct the respondents to consider the claim of the petitioner for admission into UG-Medical course MBBS/BDS under Management Quota B and C category for the

academic year 2024-25 duly allowing the petitioner to register his application through online by paying requisite fee, taking into consideration of his case under medical grounds.

Petition Under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the claim of the petitioner for admission into UG-Medical course MBBS/BDS under Management Quota B and C category for the academic year 2024-25 duly allowing the petitioner to register his application through online by paying requisite fee, taking into consideration of his case under medical grounds, by disposing of his representation dated 26.08.2024 forthwith pending disposal of writ petition.

Writ Petition No.23800 of 2024

ORDER: *(Per the Hon'ble the Chief Justice Alok Aradhe)*

Mr. N.Ramesh, learned counsel for the petitioner.

Mr. A.Sudershan Reddy, learned Advocate General for the State of Telangana duly assisted by Ms. KND.Swapna Madhuri, learned Assistant Government Pleader for Medical, Health & Family Welfare Department, appears for respondent No.1.

Mr. A. Prabhakar Rao, learned Standing Counsel for Kaloji Narayana Rao University of Health Sciences (hereinafter referred to as 'the University') duly assisted by Mr. G.Ravi, learned counsel, appears for respondent No.2.

2. With the consent of the parties, the matter is heard finally.

3. In this writ petition, the petitioner *inter alia* has prayed for the following relief:

“For the reasons stated in the accompanying affidavit, it is prayed that this Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of writ of Mandamus declaring the action of the 2<sup>nd</sup> respondent in not permitting the petitioner to register his online application for admission into MBBS/BDS course under Management Quota “B” & “C” Category for the Academic year 2024-25 pursuant to the Notification dt.17.08.2024, on the ground that the petitioner is failed to register within time schedule *i.e.*, 6:00 a.m. on 18.08.2024 to 5:00 p.m. on 23.08.2024 is illegal, arbitrary, unconstitutional and consequently direct the respondents to consider the claim of the petitioner for admission into UG-Medical course MBBS/BDS under Management

Quota "B" & "C" Category for the academic year 2024-25 duly allowing the petitioner to register his application through online by paying requisite fee, taking into consideration of his case under medical grounds and pass such other order or orders as this Hon'ble Court may deem fit and proper in the circumstances of the case."

4. Learned counsel for the petitioner submitted that inadvertently the petitioner could not register for admission under management quota "B" and "C" category i.e., NRI category. Therefore, the University is not permitting the petitioner to seek admission under Management Quota for B & C (NRI) categories. He further submitted that the petitioner be granted liberty to submit a representation to the University and the University be directed to decide the said representation in a time bound manner.

5. Learned Standing Counsel for the University submitted that the last date of registration was 23.08.2024 and thereafter, merit list has been prepared, which shall be published at the time of indicating the web options. However, it is fairly submitted by him that in case the petitioner submits a representation, the same shall be dealt with by the University in accordance with law.

6. In view of the aforesaid submission and in the peculiar facts of the case, the Writ Petition is disposed of with liberty to the petitioner to submit a representation before the University with regard to his grievance. Needless to state that in case such a representation is made, the University shall decide the same within a period of two (2) days thereafter. It is

made clear that this Court has not expressed any opinion on the merits of the matter.

Miscellaneous applications, if any pending, shall stand closed. There shall be no order as to costs.



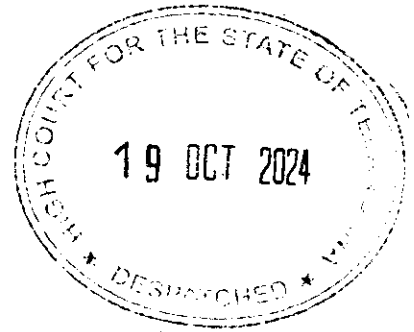
