- 2. This intra court appeal has been filed against the order dated 24.04.2024 passed by the learned Single Judge in W.P.No.10759 of 2024, by which the writ petition preferred by the appellants has been dismissed.
- 3. Learned counsel for the appellants submits that similar writ petitions, namely W.P.Nos. 8497 of 2021 and 35997 of 2022, have been allowed by the learned Single

Judge. It is submitted that on account of inadvertence, the appellants could not bring the said fact to the notice of the learned Single Judge.

- In the aforesaid fact situation of the case, the 4. appropriate remedy for the appellants is to seek review of the order dated 24.04.2024.
- The writ appeal is, therefore, disposed of with the 5. liberty to the appellants to seek review of the order dated 24.04.2024 passed by the learned Single Judge. There shall be no order as to costs.
