## THE HON'BLE SRI JUSTICE J.SREENIVAS RAO WRIT APPEAL No.1384 of 2024

JUDGMENT: (Per the Hon'ble Sri Justice J. Sreenivas Rao)

This intra court appeal has been filed by the appellants invoking the provisions of Clause 15 of the Letters Patent aggrieved by the common order dated 05.01.2024 passed by the learned Single Judge in W.P.No.223 of 2024, by which the writ petition filed by the appellants was dismissed.

- 2. Heard Mr.Shaik Jilani, learned counsel for the appellants, Mr.Muralidhar Reddy Katram, learned Government Pleader for Revenue appearing for respondent Nos.1, 2, 10, 11 and 13 to 15, Mr. Etooru Poornachander Rao, learned counsel for Government Pleader appearing for respondent Nos.3 and 6, and Mr.Mahesh Raje, learned Government Pleader appearing for respondent Nos.5, 9 and 16 to 18.
- 3. It is pertinent to mention that the learned Single Judge dismissed W.P.No.221 of 2024 and batch by way of common order dated 05.01.2024. Aggrieved by the order dated

05.01.2024 passed in W.P.No.221 of 2024, W.A.No.1342 of 2024 was filed. The Division Bench of this Court dismissed the above said writ appeal by judgment dated 29.11.2024 upholding the order passed by the learned Single Judge in W.P.No.221 of 2024.

- 4. In view of the reasons assigned in W.A.No.1342 of 2024, the writ appeal is also dismissed. There shall be no order as to costs.
- 5. The Registry is directed to enclose the copy of the judgment passed in W.A.No.1342 of 2024 dated 29.11.2024 to this order.

Miscellaneous applications pending, if any, shall stand closed.

# THE HON'BLE SRI JUSTICE J. SREENIVAS RAO WRIT APPEAL No.1342 of 2024

JUDGMENT: (Per the Hon'ble Sri Justice J. Sreenivas Rao)

This intra court appeal is filed against the common order dated 01.05.2024 passed by the learned Single Judge by which writ petition No.221 of 2024 preferred by the appellants has been dismissed.

2. Sri Shaik Jilani, learned counsel appearing behalf on of the appellants, Sri G.Veeraswamy, learned Government Pleader for General Administration appearing on behalf of respondent No. 1, Sri Etooru Poornachander Rao, learned Government Pleader for Forest appearing on behalf of respondent No.3 and Sri Mahesh Raja, learned Government Pleader for Home appearing on behalf of respondent Nos.5, 9 and 16 to 18.

### 3. Brief facts of the case:

3.1. The claim of the appellants is that the land admeasuring Ac.2400-00 gts. in Sy No.7 situated at Mansoorabad Village, Saroornagar Mandal, Ranga Reddy District was kept under the custody of the Government as caretaker by Mrs.Haneefa Bee, W/o. Mr.Burhanuddin. The said land was converted into plots of 100 Square yards each and allotted to the appellants by legal heirs of Mrs.Haneefa Bee, Mr.Md.Yousuf Khan and Mrs.Vasam Tulsamma by way of memorandum of gift executed in favour of the appellants. Originally, land admeasuring Ac. 10,000-00 gts. was patta land and it was taken into custody of the Government in the year 1947. The patta of Mrs.Haneefa Bee is evidenced by Muntakhab and Sethwar No.1262/1352 Fasli.

3.2. It is further claim of the appellants that Mr.Md.Yousuf Khan submitted representation to the revenue authorities for conducting survey, demarcation and fixing of boundary stones in

respect of the subject property, but the same was not considered. At that stage, said Mr.Md.Yousuf Khan had filed W.P.Nos.32509 of 2010 and 9067 of 2011 and the learned Single Judge of the erstwhile High Court for the State of Andhra Pradesh, disposed of the said writ petitions on 04.02.2011, directing the revenue authorities to conduct survey, demarcate and fix the boundary stones in respect of the land in Sy. Nos. 1 to 14 and 15 to 20. Pursuant to the said order, the Deputy Inspector of Survey and Land Records, Ranga Reddy District issued notices for conducting survey vide Lr.Nos.A4/3062/2013, 02.09.2013 and A4/3062/2013, dated 17.09.2013 respectively and survey was conducted on 02.09.2013 and 17.09.2013.

3.3. Thereafter, the appellants and others have filed W.P.No.26934 of 2018 and batch, seeking direction to the respondents therein not to dispossess the appellants and others from the lawful possession of the property covered by Sy.No.7, admeasuring

100.00 Sq.Yards of each of the appellants situated Saroornagar Mandal, Mansoorabad Village, at Ranga Reddy District. The learned Single Judge disposed of the said batch of writ petitions on 30.08.2018, granting liberty to the appellants to avail the common law remedy for establishing their title. Inspite of availing the said remedy, appellants have submitted representation to the respondent authorities on 20.03.2023, for release of the land admeasuring Ac.2400-00 gts. in Sy.No.7, situated at Mansoorabad Village, Saroornagar Mandal, Ranga Reddy District. When the respondent authorities failed to consider the said representation, appellants approached this Court and filed W.P.No.221 2024, seeking direction to respondent authorities to release the entire land, which was kept under the custody of the Government as caretaker by the original pattedar. The learned Single Judge has dismissed W.P.No.221 of 2024 along with the batch by way of common order dated 01.05.2024, inter alia on the ground that the appellants were never in

possession of the subject property and further held that the question of transferring the land to the appellants without possession and under alleged memorandum of gift deed is baseless and further observed that in W.P.No.26934 of 2018 and batch, the learned Single Judge granted liberty to the appellants to pursue the Civil law remedy. But the appellants without pursuing the said remedy filed W.P.No.221 of 2024 and batch. However, learned Single Judge, while dismissing the writ petitions, granted liberty to the appellants to approach the concerned authorities for allotment of 2 BHK houses and avail welfare schemes introduced by the Government. Thus, aggrieved by the said order, appellants have filed the present writ appeal.

### 4. Submissions of learned counsel for the appellants:

4.1. Learned counsel for the appellants contended that the appellants are landless poor persons and they are entitled to release of the subject land as per the gift settlement deed executed by Mrs. Haneefa

Bee in the year 1947 and the subject land is under the custody of the Government. In such circumstances, the learned Single Judge ought not to have dismissed W.P.No.221 of 2024.

### 5. Analysis of the case:

5.1. This Court considered the rival submissions made by the learned counsel for the appellants and perused the material available on record. It is undisputed fact that the appellants in earlier round of litigation approached this Court and filed W.P.No.26934 of 2018 and batch, seeking direction to respondents not to dispossess the appellants from the subject property covered by Sy.No.7. The learned Single Judge had disposed of the said batch of writ petitions on 30.08.2018 and the operative portion of the said order reads as follows:

"In the considered opinion of this Court, the disputed facts with regard to the identity of the property cannot be gone into under Article 226 of the constitution of India. However, keeping it open for the petitioners herein to avail the common law remedy for establishing their title, these writ

petitions are disposed of. There shall be no order as to costs".

5.2. The above said order clearly reveals that the disposing of Judge while Single learned W.P.No.26934 of 2018 and batch, granted liberty to the appellants to avail the common law remedy for establishing their title. The said order has become binding upon the appellants. The and appellants instead of availing the common law remedy i.e., approaching the competent Civil Court before the submitted representation revenue authorities on 20.03.2023 for release of the land to an extent of Ac. 2400-00 gts. in Sy.No.7 situated at Mansoorabad Village, Saroornagar Mandal, Ranga Reddy District and filed W.P.No.221 of 2024 seeking direction to the respondent authorities to release the above said land. The learned Single Judge while dismissing the writ petition rightly observed that the donors/original owners of the appellants were never in possession of the subject land and the question of transferring the said land to the appellants without possession and under the alleged memorandum of gift deed is baseless. However, the learned Single Judge granted liberty to the appellants to approach the concerned authorities for allotment of 2 BHK houses and avail welfare schemes introduced by the Government.

5.3. It is pertinent to mention that the appellants have raised several disputed questions of facts in the writ petition in respect of the subject property. In earlier round of litigation in W.P.No.26934 of 2018 and batch, the learned Single Judge while disposing of the writ petitions directed the parties to avail common law remedy, by its order dated 30.08.2018. The appellants without availing such remedy for establishing their title, approached this Court and filed W.P.No.221 of 2024 and the earned Single Judge has rightly dismissed the said writ petition.

- 6. For the foregoing reasons, this Court does not find any ground to interfere with the impugned order passed by the learned Single Judge.
- 7. Accordingly, the writ appeal is dismissed. No costs.

As a sequel, miscellaneous petitions, pending if any, shall stand closed.
