NOTIFICATION

Ref:- High Court's Notification No. 9/2023 dt 11- 01-2023, inviting applications for direct recruitment to the posts of Office Subordinate in the service of the High Court for the State of Telangana.

- Note : 1) The Candidates have to bring hall ticket of the written examination, along with the call letter of the oral interview, and also the requisite original certificates on the day of oral interview.
- 2) The candidates who have not submitted any of the required certificates on the day of certificate verification, are instructed to bring the same (original and 2 copies attested by the Gazetted officer) on the day of oral interview without fail, otherwise they will not be permitted to attend for oral interview.
